Accordingly, this Privacy Policy clarifies how your information and collected data can be used and stored. Making you aware and in accordance with how we will use your information and data. 1. About data collection

The information provided by you: we collect personally identifiable information - such as name, telephone, email, institution or company you work for, position, product of interest and your need or question - by filling in the registration form.

2. Navigation information on the website

When you visit our website, a cookie is inserted in your browser through services such as Google Analytics and HubSpot. The access history allows you to identify how many times you return to our address because information such as IP address, geographic location, source of reference, type of browser, duration of visit and pages visited are collected. Contact history: we store information about all contacts already made with our users. About the data generated in the use of the contact register, such as name, email and telephone, will be known to us and also location data such as country, city and state where the access is taking place and information about your browser.



3. About the use of your data

The data we collect is used exclusively for the provision of our services and we are careful to preserve your privacy. Therefore, all data and information is treated as confidential, and we will only use it for the purposes described here and authorized by agreement with this Policy. The data requested in the form can be used for self-assessment of our service, creation of new services and direct improvement of our work. Your e-mail is used for the return operation of the contact made with the registration and sending of the material or information requested by you when filling out the form.
